- 透明与合规：**本公司及其子公司将在全球范围内推行透明化运营，确保所有业务活动符合相关国际标准和法律法规。同时，我们将定期审查和更新相关政策，以适应不断变化的法律和社会要求。
- 员工权益保障：**我们尊重并保护每一位员工的基本人权，包括但不限于平等就业、自由选择职业、合理的工作时间和薪酬等。公司禁止任何形式的歧视和剥削行为，并为员工提供安全、健康的工作环境。
- 培训与教育：**本公司将定期对员工和供应商进行反奴役和反人口贩卖相关知识的培训，提高全体员工及合作伙伴的法律意识和社会责任感。

责任追究

任何违反本声明的行为都将受到公司内部纪律处分，并视情节严重程度，依法移送司法机关处理。同时，公司将保留追究相关责任人法律责任的权利。

Anti-Slavery and Anti-Human Trafficking Statement

Transparency and Compliance:** The Company and its subsidiaries are committed to promoting transparent operations worldwide and ensuring that all business activities comply with relevant international standards and legal requirements. We will regularly review and update relevant policies to keep pace with evolving legal and social expectations.
- 4. Protection of Employee Rights:** We respect and protect the fundamental human rights of every employee, including but not limited to equal employment opportunities, freedom to choose employment, reasonable working hours, and fair compensation. The Company prohibits all forms of discrimination and

exploitation and is dedicated to providing a safe and healthy working environment for all employees.

5. **Training and Education:** The Company will conduct regular training sessions on anti-slavery and anti-human trafficking for employees and suppliers to enhance legal awareness and social responsibility across the organization and among partners.
